The Democratic Republic of Sao Tome and Principe (RSTP)) has received financing from the African Development Fund (ADF) and African Development Bank (AfDB) as administrators of the Transitional Support Facility (TSF) towards the costs of an *Institutional Support Project for Customs Administration and Public Expenditure Management (ISP-CAPEM)* and intends to apply part of the agreed amount for this grant to payments under a contract for an **individual Consultant for undertaking a Training needs assessment (TNA) and Preparing a Training Plan**. The Project was approved on 28 November 2023. The overarching development objective of the project is to improve revenue collection and strengthen capacity in public expenditure management through modernized customs administration, improved expenditure management and oversight. This will be done through (a) customs administration modernization and sustainable public debt management aimed at increasing collection of trade revenue, improving efficiency and effectiveness on controlling legitimate trade operation, and preventing growth of public debt to unsustainable levels ; and (b) strengthening public expenditure management and oversight through designing and upgrading financial management systems and enhancing transparency and accountability in the use of public resources.

The assessment will cover the following project beneficiaries: Coordination and Monitoring Office of the Tender System-COSSIL; General Inspectorate of Finance-GIF; Office for the Reform of Public Finances-GARFIP; Department of Information Technology-DITEI; Department of Public Accounting; and Others Departments related with Public Finance.

The duration of the assignment is 40 working days.

The Ministry of Economy and Finance invites qualified individual consultants to indicate their interest in providing the services for undertaking a training needs assessment (TNA) and preparing a training plan. Interested individual consultants must provide information indicating that they are qualified to perform the services (description of similar tasks, experience in similar conditions, availability of appropriate skills, a current resume, a cover letter, and if possible, a (list of at least three references).
